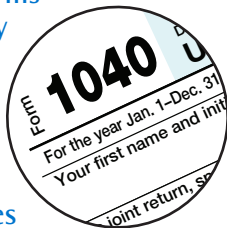

Tax Time Again

Tax Day is Friday, April 15, 2022

You must submit your 2021 tax forms electronically or have them postmarked by Thursday, April 15, 2022. But even if you wait until the last moment to file your taxes, there are three things you can do right now to lessen the stress.



1. Get a set of folders or large envelopes and label them for your various tax documents. As you receive tax information from your employer, the Credit Union and any other financial institutions, any investments you hold and so on, place them in the appropriate folder.
2. Make a folder for possible tax deductions as well. Go through your year's receipts and pull out those related to real estate taxes, charitable donations, medical expenses, etc., and place them in the folder. Dig out your 2020 return to help you remember what you claimed previously.
3. If you are eligible, contribute to your Individual Retirement Account. You have until tax day to do so, but the sooner the better. Because the interest is accumulating tax free, you will want to maximize the time you have your money tucked away for retirement. For complete details, contact your tax advisor.

Electronic Tax Document Info

PFCU mails tax documents out prior to January 31, 2022 to any member who has not signed up to receive those documents electronically on our home banking site by December 27, 2021.
